# **Get to know XAT**

Hey! Everyone....Welcome to CATKing Family. I am here to guide you about XAT. So, what exactly is XAT?

XAT is a national-level management entrance examination conducted by XLRI, Jamshedpur for admission to MBA/PGDM programmes. Apart from XLRI and 10 other XAMI member colleges, over 1,000 B-schools accept XAT scores for admission to their post-graduate management programmes. The XAT question paper consists of 100 Multiple Choice Questions (MCQs) from Decision Making, Verbal & Logical Ability, Quantitative Ability & Data Interpretation and General Knowledge. - \*Negative marking for unattempted questions is like -
- (0-8) unattempted questions no marks deducted
- >8 unattempted questions (0.1 \* no of questions) marks are deducted
- for eg:- if 7 unattempted 0 marks deducted
  - if 8 unattempted 0 marks deducted
  - if 10 unattempted 0.1 \* (10-8) = 0.2 marks deducted
  - if 12 unattempted 0.1 \* (12-8) = 0.4 marks deducted

Phase 1 (Till 25 Dec):-

#### For Quants and DI:-

- 1.Geometry Full formula based, therefore make notes of it
- 2. Focus on Data Sufficiency, watch Dashboard videos for conceptual clarity
- 3. Prepare basics of trigonometry
- 4. Practice Bar, Line, and Pie graphs questions

#### **For Decision Making**

- 1.It is kind of combination of Critical Reasoning and Verbal Ability
- 2. Practice different types of questions based on Ethical Dilemma, Strategic Decision, Business Decision, Behavioural/Personal, Plan of Action/Course of Action, and Quant/LR based Decision making questions.

#### **Verbal Ability**

- 1. For Reading Comprehension, practice Direct and Inference Type Questions
- 2. For Poems, don't go for literal meaning
- 3. Focus on Critical Reasoning, Vocabulary, and Grammar















### **Mocks Strategy**

- 1. Target 17-18 correct questions both in QADI or Verbal sections, and
- 12 questions each in other 2 sections
- 2. Daily 1 hour Decision Making practice
- 3. Practice from PYQs
- 4. Everyday read Aeon Essays at least for 30 mins
- 5. Prepare all the conceptual questions
- 6. Prepare Critical Reasoning from GMAT official Guide

Q1. Rajnish bought an item at 25% discount on the printed price. He sold it at 10% discount on the printed price. What is his profit in percentage?

**A1.** Let's assume that the printed price is  $\[mathbb{T}$  100. Cost Price = 25% discount on the printed price =  $\[mathbb{T}$  75. Selling Price = 10% discount on the printed price =  $\[mathbb{T}$  90. Profit = SP - CP =  $\[mathbb{T}$  90 -  $\[mathbb{T}$  75 =  $\[mathbb{T}$  15 Profit % =  $\[mathbb{T}$  15/75×100 = 20%

Q1. Ramesh bought a mobile from a local store. He paid 1/6 of the price via UPI and 1/3 of the price via cash. He agreed to pay the balance amount a year later. While paying back the balance amount, Ramesh paid 10% interest on the balance amount. If the interest paid was Rs. 6000, what was the original price of the mobile? (XAT 2025)

#### **A1.**

Let us take total price as 6x.

Therefore money paid through UPI = x Cash = 2x

Remaining amount to be paid = 3x Interest = 0.3x

Interest Paid = 6000 = 0.3x

x = 20000

Total Amount = 6x = 120000

The correct answer is 1.

For each room, the single occupancy charge is Rs. 2000 per day, the double occupancy charge is Rs. 3000 per day, and the triple occupancy charge is Rs. 3500 per day. If there are 55 people staying in the hotel today, what is the maximum possible revenue from room occupancy charges today.

A3. The person revenue from each room is 2000,1500 & 1166.67 respectively. Maximum revenue is from single occupancy room, so need to maximise it. Let X,Y &Z be the number of single, double & triple occupancy rooms respectively.

 $X + \dot{Y} + Z = 25$ 

The number of occupants = X+2Y+3Z=55 If Z=0, X+Y=25 & X+2Y=55 , on solving this Y=30 - This is not possible. If Z=1, X+Y=24 & X+2Y=52 , on solving this Y=28 - This is not possible. If Z=2, X+Y=23 & X+2Y=49 , on solving this Y=26 - This is not possible. If Z=3, Z=4 is not possible. If Z=4, Z=4 is not possible. If Z=4, Z=4 is not possible. If Z=5, Z=4 is not possible.

Hence, to maximize the revenue, we have to use 20 room of double occupancy and 5 rooms of triple occupancy. Hence, the total revenue will be  $20 \times 3$ ,  $000 + 5 \times 3.500 = 77$ , 500

Therefore the answer is option 5.
