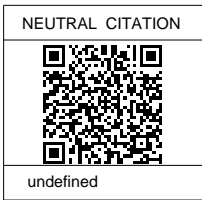

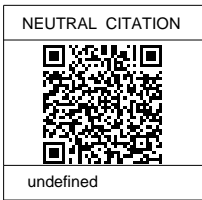
2. Heard learned advocate Mr.Vimal Jha alongwith the learned advocate Mr.Siddhant K. Gujarathi for learned advocate Mr.D.M.Devnani for the plaintiff and learned advocate Mr.Darshan Kabra for learned advocate Mr.Manav Mehta for the defendant No.1.



3. Learned advocates has placed on record the Purshish dated 15.05.2024 duly signed by the learned advocates viz. Mr.Vimal Jha and Mr.Dharmesh Devnani for the plaintiff alongwith the undated communication addressed by the plaintiff to Mr.Rakesh *inter alia* stating that the issue has been settled between the parties. The same are taken on record. A copy of the email dated 15.05.2024 is also placed on record which is taken on record.

4. Learned advocate Mr.Vimal Jha for the plaintiff submits that in view of the above purshish dated 15.05.2024, the dispute has been settled between the parties and plaintiff wants to withdraw the suit unconditionally.

5. Learned advocate Mr. Darshan Kabra for defendant No.1 also submits that the dispute between the parties has been settled and also further admits, upon



instructions, the contents of the Purshis dated 15.05.2024.

7. In view of the above, following order is passed.

7.1 The suit is disposed off as withdrawn unconditionally. The order dated 11.05.2024 passed by this Court, is hereby vacated.

7.2 Accordingly, the Defendant Vessel is released forthwith.

7.3 The Registry is directed to issue release warrant forthwith.
