

ORAL ORDER

- 1. Rule returnable forthwith. Learned APP waives service of notice of rule for and on behalf of the respondent-State.
- 2. The present application is filed under Section 439 of the Code of Criminal Procedure, 1973, for regular bail in connection with the FIR being *C.R. No.11207002230636 of 2023 registered with the Godhra City 'B' Division Police Station, Panchmahal,* for the offence punishable under Sections 465, 467, 468, 471, 34 and 120B of the Indian Penal Code.
- 3. Learned advocate appearing on behalf of the applicant submits that the present bail application is preferred by the applicant after submission of chargesheet. He further submits that all the offences are exclusively triable by the Court of




Magistrate. He further submitted that the present applicant – accused was arrested on 29.12.2023 and since then he is in jail. Learned advocate further submits that he is the retired Talati and in contact with the accused no.1. It is alleged that the present applicant has supported to the main accused, except that, no any other allegations levelled against him. He further submits that the present applicant – accused has not received any monetary gain from the said transaction. The entire case of the prosecution hinges upon the documentary evidence and all those documents have already been collected by the IO during the course of investigation. Therefore, there is no chance to tamper with the documents. Considering the above-stated factual aspect as well as role attributed to the applicant-accused, the applicant may be enlarged on bail on any suitable terms and conditions.

- 4. The learned APP appearing on behalf of the respondent-State has opposed grant of regular bail looking to the nature and gravity of the offence. It is submitted that the by making cursorily glance upon the compilation of the chargesheet papers, the role of the present applicant is clearly spelt out. Learned APP has submitted that considering the role attributed to the applicant-accused, this is a fit case wherein discretionary power of this Court is not required to be exercised in favour of the applicant-accused.
- 5. The learned advocates appearing on behalf of the respective parties do not press for further reasoned order.



- 6. I have heard the learned advocates appearing on behalf of the respective parties and perused the papers of the investigation and considered the allegations levelled against the applicant and the role played by the applicant. This Court has also considered the following aspects;
- a) That the investigation has already been completed and charge-sheet has also been filed;
- b) That all the offences are exclusively triable by the Court of Magistrate;
- c) That the entire case of the prosecution hinges upon the documentary evidence and all those documents have already been collected by the IO during the course of investigation;
- 7. This Court has also taken into consideration the law laid down by the Hon'ble Apex Court in the case of **Sanjay Chandra v. Central Bureau of Investigation**, reported in [2012]1 SCC 40.
- 8. In the facts and circumstances of the case and considering the nature of the allegations made against the applicant in the FIR, without discussing the evidence in detail, *prima facie*, this Court is of the opinion that this is a fit case to exercise the discretion and enlarge the applicant on regular bail.
- 9. Hence, the present application is allowed and the



applicant is ordered to be released on regular bail in connection with the FIR being *C.R. No.11207002230636 of 2023 registered with the Godhra City 'B' Division Police Station, Panchmahal,* on executing a personal bond of Rs.15,000/- (Rupees Fifteen Thousand only) with one surety of the like amount to the satisfaction of the trial Court and subject to the conditions that he shall;

- [a] not take undue advantage of liberty or misuse liberty;
- [b] not act in a manner injurious to the interest of the prosecution;
- [c] surrender passport, if any, to the lower court within a week;
- [d] not leave the State of Gujarat without prior permission of the Sessions Judge concerned;
- [e] mark presence before the concerned Police Station on alternate Monday of every English calendar month for a period of six months between 11:00 a.m. and 2:00 p.m.;
- [f] furnish the present address of residence to the Investigating Officer and also to the Court at the time of execution of the bond and shall not change the residence without prior permission of this Court;
- 10. The authorities will release the applicant only if he is not required in connection with any other offence for the time being. If breach of any of the above conditions is committed, the Sessions Judge concerned will be free to issue warrant or take appropriate action in the matter.



11. Bail bond to be executed before the lower Court having jurisdiction to try the case. It will be open for the concerned Court to delete, modify and/or relax any of the above conditions, in accordance with law. At the trial, the trial Court shall not be influenced by the observations of preliminary nature qua the evidence at this stage made by this Court while enlarging the applicant on bail.

Rule is made absolute to the aforesaid extent. Direct service is permitted.
