



ORAL ORDER

- 1. Rule. Learned APP waives service of notice of Rule on behalf of respondent-State.
- 2. This application is filed under Section 439 of the Code of Criminal Procedure for regular bail in connection with F.I.R. No.11200007240508 of 2024 registered with Bhilad Police Station, District Valsad.
- 3. Learned advocate for the applicant submits that considering the nature of offence and role attributed to the applicant, the applicant may be enlarged on regular bail by imposing suitable conditions.



- The learned APP appearing for the respondent 4. State vehemently submits that the applicant is having other criminal antecedents similar in nature. It is further submitted that investigation of the present offence is still in progress. He, therefore, submits that the offences which have been charged, in nature and looking to the are serious facts well as the allegations as against the applicant, no discretion required to be exercised.
- 5. I have heard learned advocates appearing for parties. of the As per the case the prosecution, the applicant had promised the of first informant selling the had collected ornaments and a sum Rs.50,000/- from him and the gold which was handed over by the present applicant to the first informant was subsequently found not to be gold. Having regard to the seriousness of offences and allegations levelled against the present applicant, the present application deserves to be allowed.
- 6. This court has also considered the following




aspects:

- (a) As per catena of decisions of Supreme Court, there are mainly factors which are required to be considered by this court i.e. prima facie case, availability of Applicant time accused at the of trial and tampering and hampering with the witnesses by the accused.
- (b) That the learned Advocate for the Applicant has submitted that the Applicant Accused is not likely to flee away.
- (c) That the Applicant is in custody since 04.04.2024.
- (d) The law laid down by the Hon'ble Apex Court in the case of Sanjay Chandra v. C.B.I. Reported in (2012) 1 SCC 40.
- 7. In the facts and circumstances of the case and considering the nature of allegations made in the FIR and without discussing the evidence in details as well as without going into details, prima-facie, this Court is of the opinion that this is а fit case to the discretion exercise to enlarge the applicant on bail. Hence, the application is allowed and the applicant is ordered to be released on bail in connection with the




aforesaid FIR, on executing a bond of Rs.10,000/- with one surety of the like amount to the satisfaction of the trial Court and subject to the conditions that;

- (a) shall not directly or indirectly make any inducement, threat or promise to any person acquainted with the fact of the case so as to dissuade from disclosing such facts to the Court or any Police Officer or tamper with the evidence.
- (b) shall maintain law and order and not to indulge in any criminal activities.
- (c) shall furnish the documentary proof of complete, correct and present address of residence to the Investigating Officer and to the Trial Court at the time of executing the bond and shall not change residence without prior permission of the trial Court.
- (d) shall provide contact numbers as well as the contact numbers of the sureties the Trial Court. In before case of change in such numbers inform in writing immediately to the trial Court.
- (e) shall file an affidavit stating immovable properties whether self



acquired or ancestral with description, location and present value of such properties before the Trial Court, if any.

- (f) shall not leave India without prior permission of the Trial Court
- (g) surrender passport, if any, to the Trial Court within a week. If accused does not possess passport, shall file an Affidavit to that effect.
- (h) shall not enter into areas of Valsad and Bhilad police station till conclusion of trial except to attend the trial.
- The authorities concerned shall release the 8. applicant only if he is not required connection with any other offence for the time being. If breach of any of the above conditions is committed, the Sessions Judge concerned will be free to issue warrant or take appropriate action in the matter. Bail bond to be executed before the lower court having jurisdiction to try the case. It will be open for the concerned Court to delete, any of modify and/or relax the above conditions in accordance with law.



- 9. At the trial, the concerned trial Court shall not be influenced by the *prima facie* observations made by this Court in the present order.
- 10. Rule made absolute to the aforesaid extent.

 Direct service is permitted.
