ORAL ORDER

- 1. **Rule.** Learned APP waives service of notice of Rule on behalf of respondent-State.
- This application is filed under Section 439 2. of the Code of Criminal Procedure for regular bail in connection with F.I.R. No.11191011240010 of 2024 registered with D.C.B. Police Station, District Ahmedabad.
- 3. Learned advocate for the applicant submits that considering the nature of offence and role attributed to the applicant, the applicant may be enlarged on regular bail by imposing suitable conditions.



- The learned APP appearing for the respondent 4. State vehemently submits that the applicant was caught with one fire arm and six live cartridges and he was found at the place of incident. Thus, there was active an participation of the present applicant in of offence in commission question. She, therefore, submits that the offences which have been charged, are serious in nature and facts looking to the as well as the allegations made against the applicant, no discretion would be required to be exercised.
- 5. I have heard learned advocates appearing for the parties and perused the papers of investigation. From the record it appears that the investigation is over and Chargesheet has already been filed. As per the the prosecution, the case of present applicant along with other co-accused was commit offence planning to of dacoity, however, no offence was actually committed and before committing offence, the applicant was caught with fire arm and six live cartridges. Having considered these facts,



the present application deserves to be allowed.

- 6. This court has also considered the following aspects:
 - As per catena of decisions of (a) Hon'ble there mainly Supreme Court, are 3 factors which are required to be considered by this court i.e. prima facie case, availability of Applicant time of trial accused at the and tampering and hampering with the witnesses by the accused.
 - (b) That the learned Advocate for the Applicant has submitted that the Applicant Accused is not likely to flee away.
 - (c) That the Applicant is in custody since 07.01.2024.
 - (d) The law laid down by the Hon'ble Apex
 Court in the case of Sanjay Chandra v.
 C.B.I. Reported in (2012) 1 SCC 40.
- 7. In the facts and circumstances of the case and considering the nature of allegations made in the FIR and without discussing the evidence in details as well as without going into details, *prima-facie*, this Court is of the opinion that this is a fit case to



the discretion exercise to enlarge the applicant on bail. Hence, the application is allowed and the applicant is ordered to be released on bail in connection with the aforesaid FIR, on executing a bond of Rs.10,000/with one surety of the like satisfaction of the amount to the trial Court and subject to the conditions that;

- (a) shall not directly or indirectly make any inducement, threat or promise to any person acquainted with the fact of the case so as to dissuade from disclosing such facts to the Court or any Police Officer or tamper with the evidence.
- (b) shall maintain law and order and not to indulge in any criminal activities.
- (c) shall furnish the documentary proof of complete, correct and present address of residence to the Investigating Officer and to the Trial Court at the time of executing the bond and shall not change residence without prior permission of the trial Court.
- (d) shall provide contact numbers as well as the contact numbers of the sureties before the Trial Court. In case of change in such numbers inform in



writing immediately to the trial Court.

- file affidavit (e) shall an stating immovable properties whether self acquired or ancestral with and description, location present value of such properties before the Trial Court, if any.
- (f) shall not leave India without prior permission of the Trial Court
- (g) surrender passport, if any, to the Trial Court within a week. If accused does not possess passport, shall file an Affidavit to that effect.
- (h) shall not leave territory of the State of Gujarat without prior permission of the concerned trial court.
- 8. The authorities concerned shall release the applicant only if he is not required in connection with any other offence for the time being. If breach of any of the above conditions is committed, the Sessions Judge concerned will be free to issue warrant or take appropriate action in the matter. Bail bond to be executed before the lower court having jurisdiction to try the case. It will be open for the concerned Court to delete, modify and/or relax any of the above



conditions in accordance with law.

- 9. At the trial, the concerned trial Court shall not be influenced by the prima facie observations made by this Court in the present order.
- 10. Rule made absolute to the aforesaid extent. Direct service is permitted.
