ORAL ORDER

- 1. Rule. Learned APP waives service of notice of Rule on behalf of respondent-State.
- 2. This application is filed under Section 439 of the Code of Criminal Procedure for regular bail in connection with F.I.R. No.11208052230711 of 2023 registered with Bhaktinagar Police Station, District Rajkot.
- 3. Learned advocate for the applicant submits that considering the nature of offence and role attributed to the applicant, the applicant may be enlarged on regular bail by imposing suitable conditions.




- The learned APP appearing for the respondent 4. State vehemently submits that Rs.8 Lakhs out of Rs.98 Lakhs had been deposited in the account of present applicant, which has been recovered from the present applicant. played applicant had an active role in commission of alleged offence in question. He, therefore, submits that the offences which have been charged, are serious nature and looking to the facts as well as the allegations made against the applicant, no discretion is required to be exercised.
- 5. I have heard learned advocates appearing for the parties and perused the papers of investigation. From the record it appears that the investigation is over and Chargehas already been filed. The attributed to the present applicant is to the effect that the applicant had deposited of Rs.8 Lakhs out Rs.98 Lakhs in his the statement made account. As per Additional Public learned Prosecutor Mr. Mehta, the amount deposited in the account of present applicant, has been recovered from the present applicant. Considering the



aspect that amount from applicant has already been received and all the material is on record, the present application deserves consideration.

- 6. This court has also considered the following aspects:
 - (a) As per catena of decisions of Hon'ble Court, there are mainly Supreme factors which are required considered by this court i.e. facie case, availability of Applicant accused time of at the trial and tampering and hampering with the witnesses by the accused.
 - (b) That the learned Advocate for the Applicant has submitted that the Applicant Accused is not likely to flee away.
 - (c) That the Applicant is in custody since 24.11.2023.
 - (d) The law laid down by the Hon'ble Apex Court in the case of Sanjay Chandra v. C.B.I. Reported in (2012) 1 SCC 40.
- 7. In the facts and circumstances of the case and considering the nature of allegations made in the FIR and without discussing the evidence in details as well as without going into details, prima-facie, this Court is of



the opinion that this is a fit case to exercise the discretion enlarge to the applicant on bail. Hence, the application is allowed and the applicant is ordered to be released on bail in connection with the aforesaid FIR. executing bond of on a Rs.10,000/with one surety of the satisfaction of amount to the the Court and subject to the conditions that;

- (a) shall not directly or indirectly make any inducement, threat or promise to any person acquainted with the fact of the case so as to dissuade from disclosing such facts to the Court or any Police Officer or tamper with the evidence.
- (b) shall maintain law and order and not to indulge in any criminal activities.
- (c) shall furnish the documentary proof of complete, correct and present address of residence to the Investigating Officer and to the Trial Court at the time of executing the bond and shall not change residence without prior permission of the trial Court.
- (d) shall provide contact numbers as well as the contact numbers of the sureties before the Trial Court. In case of



change in such numbers inform in writing immediately to the trial Court.

- shall file an affidavit stating (e) immovable properties whether self acquired or ancestral with location present description, and value of such properties before the Trial Court, if any.
- (f) shall not leave India without prior permission of the Trial Court
- (g) surrender passport, if any, to the Trial Court within a week. If accused does not possess passport, shall file an Affidavit to that effect.
- 8. The authorities concerned shall release the applicant only if he is not required connection with any other offence for the time being. If breach of any of the above conditions is committed, the Sessions Judge concerned will be free to issue warrant or take appropriate action in the matter. Bail bond to be executed before the lower court having jurisdiction to try the case. It will be open for the concerned Court to delete, modify and/or relax any of the conditions in accordance with law.



- 9. At the trial, the concerned trial Court shall not be influenced by the *prima facie* observations made by this Court in the present order.
- 10. Rule made absolute to the aforesaid extent.
